Very Busy. Lots of focus on RV's. Lots of time on Little Orchard. Prostitution at night has been reduced through efforts by SJPD, but it's a work in progress. Focusing on neighborhood quality of life. Needs resources. Can start to junk RV's with new ordinances. If RV's do not have current Registration and are beyond 6 months, they can impound it. Can't legally force people out of a "lived-in" rv, but unoccupied will be towed. The City Attorney is going after the "Vanlords". Trying to get a restraining order. New Ordinance coming for Vanlording.

D. OED

City has received \$209K from BID payments - CoSJ Finance will distribute incrementally. There are grants for Store Front improvements or beautification up to \$10k. Positive optimism plays a role in vitalization. Must keep trying to remove blight. Vibrancy can be the thing we need to recover/regain normalcy. Preliminary talks about a special project at the fairgrounds. Glimmer of hope when the county Builds out the fairgrounds. *Note*: Invite the County rep back for a meeting.

Some zoning has changed to accommodate future development. Possibly the OED may have a general plan for our area. Rezoning was done to work with a consistent general plan.

## E. Small Business Ally Program

Helps businesses w/ permits. Businesses with 35 employees or less. Help franchises and large businesses can come to OED and they will direct them to the right dept. Must have a business license. Must have at least 1 year on the lease, if renting. Average costs have been around \$5K To help businesses get into compliance.
